

Information on the processing and handling of personal data in accordance with Transparency Regulation Art 12 ff DSGVO VS 1-18

Intended purpose

Our company processes and processes personal data for the purpose of establishing business relationships and fulfilling orders. All data categories for the fulfilment of pre-contractual and contractual obligations are affected. Personal data will only be passed on to third parties if this is necessary to fulfil the business purpose. Personal data will not be passed on to third parties who are not involved in the business purpose, or only if the consent of the data subject has been obtained.

The collection, processing and use of personal data is carried out within the framework of the legally permissible pursuant to Art. 5 and 6 DSGVO and in accordance with the guidelines 'General principles for data processing of personal data' (§§ 47 and 48 BDSG-neu). If personal data are collected from the data subject, the data subject has the right to transparent information in accordance with Art. 12 ff DSGVO in accordance with § 32 BDSG-neu. In principle, only such information is processed and used that is necessary for the fulfilment of operational tasks and is directly related to the purpose of processing. The special requirements for the collection, processing and use of special categories of personal data pursuant to Art. 9 DSGVO and Sections 22 and 48 BDSG-neu are observed. According to the DSGVO, the processing and handling of sensitive data is only permitted under the principle of the reservation of permission or upon submission of a legal basis.

The rights of those concerned

Within the scope of the legal norms DSGVO and BDSG-neu, data subjects have the right to information according to § 57 BDSG-neu, correction and deletion as well as restriction of processing according to § 58 BDSG-neu and objection against the processing of their data according to Art 21 DSGVO. Written form is required for this purpose. The data is automatically deleted if the purpose for its storage no longer applies and no other legal norm (e.g. retention period) precludes a deletion.
